

## SELF-DECLARATION AND COMMITMENT FORM

### DECLARE

- a) to have read and understood the privacy notice relating to the processing of data for the purpose of contrasting the "Covid-19";
- b) that I have been informed about and understood the obligations and provisions for the containment of the Covid-19 outbreak;
- c) that I am aware of the obligation to remain at home in the presence of fever (over 37.5°) or other influenza symptoms and to call my family doctor and the competent Health Authority;
- d) to be aware of the obligation provided for by art. 20 paragraph 2 letter e) of Legislative Decree 81/2008 to immediately inform Marina Chiara S.r.l., the Site manager or the person in charge of dealing with any risk situation for health and safety at the Site, including flu symptoms, temperature, coming from risk areas or contact with people positive for the virus in the previous 14 days and in all cases where the Authority's measures require you to inform the family doctor and the Health Authority and stay at home, and therefore
- e) that the completion of this form also certifies the conditions set out in points (a), (b), (c) and (d) in relation to any subject younger than 18 years old accompanied by me.

### I DECLARE

- ☐ that in the last 14 days I had contacts with, or I had been close to subjects tested positive for COVID-19

- ☐ that I'm having a body temperature above 37.5°C or other flu symptoms
- ☐ that I'm not having a body temperature exceeding 37.5°C or other flu-like symptoms

### I AM AWARE AND I ACCEPT

- that upon arrival I will not be allowed to enter, the Marina Chiara campsite, Voltoncino campsite, Casale Voltoncino residence and their appurtenances and facilities (all together referred as the "Structures") and that I must promptly declare if, even after entry, I develop danger conditions for which the provisions by the Authorities mandate me to inform my family doctor, the competent Health Authority, and to remain at home (including flu symptoms, temperature over 37.5°C, coming from risk areas or had been in contact with or close to people tested positive to Covid-19 in the previous 14 days);
- that I'll be subject to body temperature control at the time of access or transit through the Structures,
- that upon arrival and check-in, in case my body temperature will be scanned above 37,5°C, I will not be allowed to enter the Structures, and that I will have to contact as soon as possible my doctor/authority in charge and follow their instructions;
- that, upon subsequent entries after check-in, if my body temperature will be scanned above 37.5°, I will be temporarily isolated in a special room used for this purpose inside the Structure and, if necessary, I will be provided with a mask and I will have to contact as soon as possible my attending physician in charge and follow the instructions of the competent Health Authority; I am also aware that Marina Chiara S.r.l. will have to momentarily isolate

any other subjects with whom I had close contacts in the Structures and will immediately inform the competent Health Authorities and the emergency numbers for COVID-19 provided by the Region or the Ministry of Health;

- that, in case I am found developing symptoms during my stay at the Structures, if I am found positive to the COVID-19 swab Marina Chiara S.r.l. shall collaborate with the Health Authorities for the tracking and insulation of any possible "close contacts" I had inside the Structures in case I am found positive to the COVID-19;
- that in the case of a person found symptomatic inside the Structures, close contacts have an obligation to cautiously stay in their rooms or tents and follow the instructions of the Health Authority;
- that, in the event that the competent Health Authority arranges specific additional provisions and obligations, Marina Chiara S.r.l. SHALL provide the maximum collaboration.

### **I COMMIT MYSELF AND MINORS ACCOMPANIED BY ME**

- to respect, in the case of temperature detection above 37,5°C, the obligation of being temporarily insulated and, in this case, to immediately inform my family doctor and Health Authorities and to follow their instructions;
- to comply with all the provisions of the Authorities and regulations by Marina Chiara S.r.l. regarding access, transit and stay inside the Structures, and in particular the hygienic and personal precautions, wearing personal protective devices and equipment if required, use of common areas (bar, changing rooms, bathrooms, smoking areas, drinks and snack dispensers, etc.), organizational rules of the Structures, management of entrances and exits in the Structures, getting around the Structures, meetings between guests, internal events, training and information sessions);
- to promptly and responsibly inform Marina Chiara S.r.l. of the development of any influenza-like symptom during my stay at the Structures, taking care to stay at an adequate distance from the people nearby;
- to collaborate with Marina Chiara S.r.l. in relation to the fulfillment of my obligations to meet the provisions of the Authorities and in particular the Health Authorities
- to behave in any other way that is necessary and useful for preserving the health of individuals and the safety of the facility, its guests, employees and collaborators
